101. PREPARATION OF NGB FORM 22 (15 OCT 76) - REPORT OF SEPARATION AND RECORD OF SERVICE.--Since the new NGB Form 22 does not have a place to enter the date and place of enlistment, and to list prior service, the following procedure will be used, effective immediately, to facilitate re-enlistment of the individual at a later date: Item 19 (REMARKS) will indicate individual's date and place of current enlistment, and prior service as listed in Item 26 (MILITARY SERVICE) of DD Form 1966/2.

102. RECISSION OF PARA 301 b(5) OF 1 FEB 78 BULLETIN.--Para 301 (Interim Change to NGR 600-9) b(5) of 1 Feb 78 Bulletin is rescinded.

103. CHANGE TO 1 FEB 78 BULLETIN.--On the title page of the 1 Feb 78 Bulletin, change NUMBER 2 to read NUMBER 3.

203. INTERIM CHANGE TO AR 635-200 - PERSONNEL SEPARATIONS.--References AR 635-200 dtd July 1966 with changes, AR 635-200 dtd 21 November 1977 effective 1 March 1978.

a. Para 13-318 of Reference 1 is amended to add "When the reason for separation is unsuitability due to personality disorder (para 13-58(2)), the individual will be furnished an Honorable Discharge Certificate unless he has been convicted of an offense by General Court-Martial or has been convicted by more than one Special Court-Martial in the current enlistment period of obligated service or any extension thereof, in which case he may be furnished a General Discharge Certificate".

b. Para 13-15 Reference 2 is amended to add "When the reason for separation is unsuitability due to personality disorder (para 13-4b) plus the individual will be furnished an Honorable Discharge Certificate unless he has been convicted of an offense by General Court-Martial or has been convicted by more than one Special Court-Martial in the current enlistment period of obligated service or any extension thereof, in which case he may be furnished a General Discharge Certificate".

c. Change to Reference 1 is effective upon receipt.

d. Change to Reference 2 is effective 1 March 1978.

401. FOOD SERVICE, BASIC DAILY FOOD ALLOWANCE.--a. The BDFA for the month of March 1978 has been increased to \$2.86.

b. The maximum authorized meal purchase rates per person, based on this BDFA are as follows:

(1) Meals served in messhalls or armories:

Breakfast	\$.85	(2.86 + 50% x 20%)
Lunch	\$1.72	(2.86 + 50% x 40%)
Dinner	\$1.72	(2.86 + 50% x 40%)

(2) Commerically prepared meals served by contractors (enlisted personnel only).*

Breakfast	\$1.72	(2.86 x 3 x 20%)
Lunch	\$3.43	(2.86 x 3 x 40%)
Dinner	\$3.43	(2.86 x 3 x 40%)

* No officers may be subsisted by a contractor at Government expense. Authorized civilians in a per diem status must also purchase meals from other than Government sources.

402. FIELD WIRE REQUIREMENTS FOR ANNUAL TRAINING.--Units are reminded that WD-1 field wire will not be provided by the training site installations. Therefore, planning should include units transporting to the training site all requirements for field wire.

403. TIMELY SUBMISSION OF REQUEST FOR ISSUE (DA FORM 2765).--a. USPFO Logistics Division has regulatory time limitations on which to submit requisitions to the Supply System based upon the Priority Designator (PD) assigned to the DA 2765 by the unit. The base date of a requisition is the Julian date portion of the document number assigned by the unit. This data is captured and compiled by computers here and at the Defense Automated Address System (DAAS) through which all requisitions must pass. The information is then put in report form for use by managers in determining the efficiency of supply support elements. Response time is calculated in calendar days, not work days. Thus mailing time and weekends/holidays are a built-in delay over which we have no control but which are still recorded as calendar days against requisitioning response time.

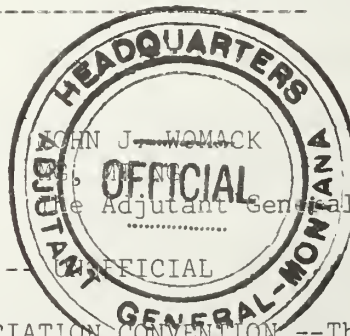
b. The above demonstrates the necessity of timely submission of DA 2765s. It is requested that Request for Issue be mailed to the USPFO the same day that the document number is assigned.
